Introducing the Catalyst™ Platform

Wiley & Sons is in the process of introducing new tools to support learning and strengthen the work culture. The tool is called Catalyst™ and represents a new learning experience for the learner and the facilitator. Everything DiSC® Catalyst™ represents the latest innovation to the DiSC® product line.

Four core components are included in the Everything DiSC Workplace Catalyst solution: 1) the Everything DiSC® Assessment, 2) the Catalyst™ platform, a personalized, on-demand mobile learning tool supporting learners, 3) Your DiSC® Profile Report (PDF) and 4) short-format, instructor-led facilitation modules tailored for virtual or in-person delivery.

Over the past several weeks, we have attended online training on Catalyst and are excited to share preliminary information with you because we believe you can put these resources to use over the summer to help manage your training programs in light of COVID-19. That is, can Everything DiSC Workplace® on Catalyst™ be the solution for your trainers to facilitate DiSC session online? The platform is targeted for a June 2020 release.

- The solution provides the ability for training departments to offer DiSC® sessions as virtual or in-person sessions. The initial roll-out will focus on facilitating online classes which excites us given the impact COVID-19 currently has on classroom-led training.
- The training modules provides the flexibility to facilitate shorten sessions—60 to 90 minute increments—over a period of time determined by your team. The short-format, modular design will make it easy to tailor your training to any group size or time constraint. Each module is self-contained and can be delivered as a standalone training.
- You will receive ‘Guided Facilitation’ lessons you can customize for your session which shortens your overall design time. Some may use the lessons as is without any design changes. These modular lessons come complete with contemporary video and learning activities designed to take advantage of advance and basic video conferencing technology. Your DiSC® Profile Report

The DiSC® report used with the Catalyst™ platform is called *Your DiSC® Profile Report*. Most of the content details are identical to the ones found in today’s Everything DiSC® Workplace Report. The minor differences are in the content organization and presentation. One primary change you will notice however is the addition of introductory pages (with learning objectives) of each content section. This will allow each section to be facilitated independently (i.e., short-modules), if desired. The guided lessons included in your Facilitation Kits will be eligible for an update to support the new report in a virtual environment.


