EPIC Credits and Supplies



As of this mailing, we have not received notification of a price increase in 2024. Based on past trends however, if there will be price increases, we will likely get notification in February with prices increases taking effect starting July 1st. We will keep you abreast of any updates with a separate email to subaccount administrators so you can plan accordingly. Let us keep our fingers crossed prices will remain as is for the new year.

Let us know when you need to order EPIC Credits. As always, we will continue to honor prices associated with multi-year contract awards. Likewise, we will provide clients requesting a single order our deepest allowable discount using our GSA pricing. We work hard to guarantee depositing EPIC credits into your account within 24 hours of order completion.

Specific to Facilitation kits (e.g. *MFR Part# A-901*), you now have the option to download them from Wiley's website allowing new trainers immediate access to the kits. This downloadable option is also ideal for

agencies with policies against using external drives on their network. Lastly, other products requiring shipment are typically delivered within 3-5 business days.

EPIC– Email Reminder Limitation

Over the summer, we heard from several clients regarding issues in their ability to send multiple reminder emails for learners to complete their assessment via EPIC. This problem occurred due to a conflict between Microsoft[™] and Wiley's EPIC® software handshake. The outcome is that the EPIC Platform now has a limited number of reminder emails that can be sent to a single learner. The underlying issue was Microsoft's software flagged multiple reminder emails as SPAM. Administrators will be limited to using the Resend Login Information <u>three times</u> per learner access code.

EPIC - Home Page Help Videos

Have you ever wanted a job aid, e.g., a video to remind you how to complete a task on the EPIC Platform? Well if you haven't discovered it yet, the *EPIC `Help' Menu* on the home page is rich with micro-learning video resources specific to EPIC administration. Simply log onto your EPIC account and click on the `Help' Menu (pictorial view below):

Add Multiple Logins on EPIC Platform

An EPIC administrator can assign multiple logins to the platform. This question recently came up with a client and we thought perhaps others may benefit. Working from your sub-account home page, follow these steps to add additional logins: *Navigate to EPIC > Manage Your Account > Manage Users.*

Batch Assign Access Codes

You can batch assign access codes for assessments when you have a large number of codes to administer. This time-saving tool has existed for a long time. As a refresher, working from your sub-account home page, follow these steps: *Navigate to EPIC >Create new report >issue codes >Product Family and Product >Report Content >Add Respondents >Import from Excel.*
